### CONDITIONS :

The Customer agrees to pay all invoices on or before the tenth day of the month following the invoice date and all unpaid amounts will bear interest at the rate of 1.5% per month, or 18% per annum, including administration fees.

A handling fee of 15% of the selling price will be charged on all merchandise returned in good condition, after prior authorization by Brunet.

In the event of Customer's default, an additional charge equal to 20% of the amount claimed or the value of the goods claimed will be added to the claim as liquidated damages.

The Customer acknowledges that Brunet shall retain sole ownership of the goods sold until full payment is made, but the Customer shall assume all risk of loss of the goods upon taking delivery thereof. Each payment made by the Customer shall be applied at Brunet's sole discretion to any indebtedness of the Customer, which Customer hereby ratifies.

The Customer certifies that the foregoing financial information is complete, true and correct and has been voluntarily disclosed and the Customer authorizes Brunet to verify the accuracy of such information with anyone.

The undersigned (the "Guarantor") jointly and severally with the Customer undertakes to assume each and every one of the Customer's obligations hereunder and waives all benefits of discussion and division. The resignation of any of the undersigned as a director, officer or employee of the Customer shall not invalidate this Guarantee for the future.

The Customer and the Guarantor declare that they have read all the terms of this Account Opening Agreement and the Guarantee and have received all the appropriate explanations on their nature and scope.
